#### Committee and Staff Reports – May- 2024

**Finance/Operations** – *Kirk Waite.* The committee will meet on May 30<sup>th</sup> to review the draft FY25 budget.

**Personnel Committee-** *Lori Ruple.* The committee will meet June 11<sup>th</sup> for annual reviews. NRPC has advertised for an additional Project Manager to assist with Clean Water Service Provider work.

**Executive Committee-** *William Irwin.* The committee met and reviewed legislative items, Healthy Roots transition, and internal procedures.

**Project Review** – Bob Buermann. Business report is enclosed. Board action required.

#### **Transportation Advisory Committee (TAC)** – Harold Garrett.

The committee met May 9<sup>th</sup>. Presentation was given by Ian Anderson, VTrans Bituminous Concrete Materials Manager, regarding VTrans 2024 Paving Spec Book updates. The committee also received a construction season update specific to projects within the region.

**Energy and Climate Committee**- *Staff, Peter Zamore, Vice-Chair.* The committee met and completed final review and endorsement of the draft energy plan.

**Brownfields Committee** – *Staff, Megan Sherlund.* The Committee did not meet this month. An RLF Loan review is underway for the Champlain Transmission site on North Winooski Ave in Burlington. Assessment and cleanup planning work is getting started or ongoing many sites throughout the region, including Abenaki Nation of Missisquoi Tribal Headquarters at 100 Grand Ave in Swanton, 124 First Street in Swanton, 6 South River Street in Swanton, 74 Lower Welden Street in St. Albans City, 20 LaSalle Street in St. Albans City, Highgate Village Core property in Highgate, 200 Bridge Street in Sheldon and 113 Main Stret in Richford. Staff continues to coordinate with the Town of St. Johnsbury on closing the loan and finalizing the grant agreement for cleanup at their Armory redevelopment project.

Regional Plan Committee- Peter Zamore. The committee met to review the draft energy plan.

Municipal Plan Review Committee –Sarah Hadd. The committee did not meet.

**Vermont Economic Progress Council (VEPC)** – *Vacant.* There are no projects proposed within the region.

**GMT-** Bob Buermann/Catherine Dimitruk. The GMT Board met and discussed: return to fares (urban area only) and planning for the fiscal cliff that will necessitate route adjustments primarily in the urban area.

#### **Staff Reports:**

#### **Transportation**

- Staff submitted NRPC TPI FY24 Work Plan amendment to VTrans Planning Manager, Matthew Arancio.
   Amendment addresses addition of FY23 unspent funds to FY24 balances, also includes addition of non-match funding for the State Rail Trail Interactive Mapping project.
- Staff met with Andy Crossman from Franklin County Trails Alliance to learn more about the organizations recently awarded Vermont Outdoor Recreation Economic Collaborative (VOREC) planning grant. The

Alliance is using the grant funds to plan for a multi-modal, mountain bike trail which will stem off trails recently built within the St. Albans Town Forest, possibly ending near the Missisquoi Valley Rail Trail in Sheldon.

- Staff submitted TPI Task 3.1.4 Climate Mitigation Planning: comments to inform the draft state EV charging plan. Comments regarding equity/inclusion, public engagement, and opportunities for training programs were included.
- Staff coordinated efforts with VTrans, Rail Trail Council members, and volunteers to ensure that all town sections of the MVRT and the LVRT within the northwest region were covered for Green-Up Day.
- NRPC is working with the Town of Montgomery on a grant application to the Active Transportation
  Infrastructure Investment Program (ATIIP), as the town seeks additional funding for the Montgomery
  Streetscape Project.
- Staff is assisting the Village of Swanton with planning and outreach for the upcoming closure of Bridge 6 on VT 78, over the Missisquoi River this summer.
- Staff is working with the Town of Fairfield to address concerns about impact to town roads and aging town bridges during the 28-day closure of Bridge 6 on VT 36, over the Fairfield River this summer.
- Staff is working with the Town of Isle La Motte and Vermont Local Roads to address resident concerns about town-maintained roads and ditches.
- Acting as municipal project manager, staff participated in kick-off meeting for Pidgeon Hill Road culvert replacement project and in an inspection meeting for Longley Bridge Road streambank restoration project.
- Corresponded with staff in South Hero regarding possible municipal project management role in US 2 scoping study.
- Acting as municipal project manager for the Montgomery Streetscape project, reviewed the draft conceptual plans prior to being submitted to VTrans.

#### **Emergency Management**

- Assisted the following communities with updating Emergency Plans: Alburgh, Berkshire, Enosburg Falls, Enosburgh Town, Fairfax, Fairfield, Fletcher, Franklin, Grand Isle, Highgate, Isle La Motte, Montgomery, North Hero, Richford, South Hero, Sheldon, St. Albans City, St. Albans Town, Swanton Town and Village.
- Participated in the second State Integrated Preparedness Planning Workshop to develop 3 -year state-wide training and exercise plan for state and local agencies and partners.
- Drafted After Action Review for Solar Eclipse Event for Swanton Village and Town public safety officials.
- Met with VEM to begin planning for region's participation in State Wide "Binary Blizzard" exercise later this
  year. The exercise is designed to test the state's response to a cyber attack on critical facilities and essential
  systems.
- Met with several new local officials regarding local EM Director and local EM Coordinator roles and responsibilities.
- Met with VEM Regional Coordinator and northern RPCs to discuss EMPG program, cooling shelter planning efforts, exercises and local trainings.
- Held Mitigation Planning Meetings with Enosburg Falls to update mitigation goals and projects section of their LHMP. Drafted communications plan, survey and flyer for residents to gain public input.
- Continued to support the Northwest Vermont Medical Reserve Corps including grants management and supporting their efforts for upcoming spring and summer events including public education campaign for campgrounds and parks including tick awareness, poison plants, sun/heat related illness prevention, and Stop the Bleed trainings.

#### GIS

- Updating the Regional Energy Plan maps using best available data following Act174 mapping standards.
- Continued updating the Community Maps of the municipalities in the Northwest Region.
- Completed draft Town Plan maps for the Town of Alburgh.
- Completed a sidewalk map for the Town of South Hero.

#### Municipal Planning

- Provided Sheldon and North Hero with zoning services.
- Staff is finalizing the deliverables from the bylaw modernization grant from ACCD to St. Albans Town (lead) and Highgate, Enosburgh, Montgomery and Sheldon: staff is finalizing zoning recommendations aimed at reducing regulatory barriers to housing choice and affordability.
- Supported the Town of South Hero's community wastewater project regroup after it was determined that a wastewater construction project is not feasible within the time constraints of the State ARPA funding.
- Supported the Town of Highgate's village wastewater project with project management assistance.
- Assisted the Town of South Hero with its VCDP Planning Grant to plan for renovations of the South Hero Meeting House.
- Assisted the Town of Grand Isle with an update to their Town Plan including reviewing a partial draft.
- Reviewed draft of the Sheldon Town Plan with the Planning Commission and made edits based on the review.
- Met with the Isle la Motte Planning Commission to review draft sections of the Isle la Motte Town Plan and plan for public outreach.
- Met with the Montgomery Planning Commission, Development Review Board and Selectboard to discuss short-term rental regulations in Montgomery.
- Met with the St. Albans Town planning staff and the project consultant for the Transportation Oriented Development (TOD) master planning and bylaw project to develop a scope of work for the project.
- Supported the Town of Enosburgh and Village of Enosburg Falls with village center designation renewal application.
- Supported the Town of Highgate with an application for Neighborhood Designation Area with maps, consideration of the boundary and zoning updates.
- Secured grants for Isle la Motte and Berkshire as part of the Municipal Technical Assistance Program.
- Supported the Town of Richford with a minor amendment to their Town Plan and Zoning Bylaws.
- Assisted the Town of Richford with developing a survey for the Richford Town Plan.
- Met with the Town of Fairfield to kick-off a project to update the zoning bylaws.
- Drafted Alburgh Town Plan sections and reviewed them with the Alburgh Planning Commission.

- Follow up communications to zoning administrators in the region with a request to fill out a permit tracking form, which is part of a new annual housing unit permit tracking program and online dashboard. The online housing dashboard will track housing development by type and location at the municipal level.
- Completed inputting the entire region's zoning information into the Vermont Zoning Atlas. The atlas is part
  of a national effort to de-mystify zoning laws, enable comparisons across jurisdictions, and illuminate
  regional and statewide trends, such as the amount of land with restrictions on multi-unit homes. The

- Continued work on Energy Efficiency and Conservation Block Grant (EECBG) application.
- Continued coordination and organization of second WindowDressers community build.
- Worked on energy plan updates for Sheldon, Grand Isle, and Alburgh

- Assisted Swanton with application for Charge Vermont grant for EV chargers
- Assisted Bakersfield and Swanton with plans and applications for Community Tree Planting Grant

Continued to address activities contained in FY 23-24 work plan, including meetings with partner organizations, and quarterly reporting. Contributed edits to final version of "Unifying Stormwater" initiative's action plan.
- Created sketch maps for sponsors of potential Carry Bay and Petts Bay Lake Watershed Action Plan.
- Attended Town of Franklin "Community Voice" meeting and served as resource team member for task force focusing on future of Lake Carmi.
- As part pf NRPC-led Regional Stormwater Education Program (RSEP), hosted an in-person workshop on construction of residential rain barrels and webinar regarding cyanobacteria. Launched planning for "Streamwise" program educational event.
- Consulted with DEC staff and with representatives of the Town of Fairfax regarding municipal bylaw changes recommended to retain enrollment in federal flood insurance program.

- Coordinated Regional Partners meetings, monthly gatherings of workforce, community and economic development organizations in the region.

- HRC continued with 5 farms as a part of a new Working Lands Enterprise Initiative Service Provider Grant in partnership with South Hero Land Trust. A new website has been developed as well as new marketing materials created to support 2 farm businesses.
- A draft of the Franklin County printed guide has been created. It is slated to be printed the end of May for distribution in June.
- A draft MOU has been created outlining HRC's transition to CVOEO. The MOU has been discussed and edited by the HRC Advisory Committee.
- Continued planning for the 2024 Northwest Farmacy CSA and Migrant Household CSA programs. Updates to program materials and outreach to farms has started.
- The HRC gleaning program has had a few early season gleans and is preparing for the busy summer season. To recruit more volunteers, we will be tabling at a couple of farmers markets in GI and Franklin Counties.
- On June 28<sup>th</sup>, a Ben & Jerry's volunteer group will help plant winter squash at our grow-for-donation farm partner in Alburgh

#### Housing For All - Working Communities Challenge

- Housing For All and NRPC launched a pilot project that provides preliminary estimates, financial support for design, and navigation services for the creation of an Accessory Dwelling Unit (ADU) or duplex. NRPC Board members and volunteers are eligible to apply. The deadline is 5:00 p.m. on June 20th. Learn more and apply on the NRPC website.
- The initiative continues work with C.I.D.E.R and the Lake Champlain Islands Economic Development Corporation to raise funds for a pilot project that provides home rehabilitation services for low-income and/or senior property owners in Grand Isle county.
- Housing For All is working with other Vermont Working Communities Challenge initiatives and the statewide steering committee to explore how we all sustain the next stages of our work.

#### **Memorandum of Understanding**

between

#### **Northwest Regional Planning Commission**

and

#### **Champlain Valley Office of Economic Opportunity**

This Memorandum of Understanding (MOU) sets forth the terms and understanding between the Northwest Regional Planning Commission (NRPC) and Champlain Valley Office of Economic Opportunity (CVOEO) regarding the Northwest Healthy Roots Collaborative (HRC) transfer to CVOEO.

#### **Background**

The Northwest Healthy Roots Collaborative (HRC) was established in 2014, to strengthen the local food system of Northwestern Vermont for the health and vitality of the community. This collective impact partnership of nonprofit and community organizations focuses on addressing food access, education and farm viability in our region. The partnership currently includes NRPC, Franklin County Development Industrial Corporation, Franklin/Grand Isle Community Action, South Hero Land Trust, the Abbey Group, Franklin County Natural Resources Conservation District, the Lake Champlain Basin Program and a network of over 160 growers and makers in Northwest Vermont.

HRC's cross-sector approach to improving food access, providing local food and nutrition education, and developing essential infrastructure and programs is critical to farm viability and the health and wellness of our Northwest Vermont communities. Through strong partnerships with regional and statewide nonprofits and service providers, HRC works with growers & makers to support strong and innovative food businesses, buyers to support local procurement and eaters to improve access to healthy local food.

#### WHO/WHAT

The Healthy Roots Collaborative is a regional food systems program supporting the growers, producers, and consumers in Franklin and Grand Isle Counties. Healthy Roots provides programs and services for both the consumers and producers in the Northwest Corner of Vermont that focuses on food education, access and infrastructure.

#### VISION

We envision a healthy Northwest Vermont with a community rooted in a strong agricultural economy with thriving farms, where all are connected to and nourished by local farms and food.

#### **MISSION**

To strengthen the local food system of Northwest Vermont for the health and vitality of our community.

#### **STRATEGIES**

**Access**- Gleaning, food purchasing, aggregation, distribution, & storage. Value chain facilitation & Northwest Vermont Grown, connection to other statewide farm service providers.

**Education**-Gleaning field trips, Northwest Farmacy CSA, NOTCH mini-fridges (branded produce), events/workshops

**Development-**Farm & Food Producer TA, food storage, commercial kitchen exploration, value chain facilitation, food box development (Northwest Farmacy CSA & Migrant Household Food Boxes)

#### **PROGRAMS:**

Farm & Food Business Support

**Gleaning/Food Access** 

Farm to School

#### **RESULTS:**

Growers & Makers: Viable, resilient, sustainable, innovative

Buyer: Buying local

Eaters: Access to healthy local food, skills to prepare & grow food

Partnerships: leveraged to build capacity and resources to further the food system

NRPC has served as the backbone organization for HRC since 2019. NRPC will transition backbone support of HRC to CVOEO effective July 1, 2024. Along with this transfer of backbone support, NRPC will also provide transitional support so there is no interruption in HRC staff benefits, develop a plan for equipment ownership, use and responsibility, and transfer any remaining grant funding to CVOEO.

#### **Purpose**

This MOU will establish CVOEO as the backbone organization for HRC and document each organization's role in the transition. Addressing food access, education and farm viability in our region and other goals of the HRC will be accomplished through the commitments outlined below.

#### NRPC will:

- Transition any current grant funding and contracts for HRC.
- Provide COBRA coverage for HRC staff for July 1-July 31st, until new insurance coverage from CVOEO starts.
- By July 31, 2024 complete a final accounting of expenses and assets and transfer any assets to CVOEO.

- Develop a plan for equipment ownership, use and responsibility. Equipment includes: Ford F-150 Powerboost, 13'x11' Walk-in Cooler, and 8'x6' Refrigerated Trailer. All equipment was purchased using funds from the Economic Development Administration, Award No: 01-79-14946.
- Provide appropriate logo for NRPC which should be included in any future branding placed on Ford F-150 truck, walk-in cooler or refrigerated trailer.
- Maintain a representative on the HRC Advisory Committee.
- Continue to partner with HRC and CVOEO as applicable on grant and donation opportunities to further the goals of HRC.
- Provide for the transfer of the HRC historical records and files, supplies, and equipment to CVOEO.

#### CVOEO will:

- Provide program, fiscal and administrative oversight for the HRC with advice and support of the HRC Advisory Committee as outlined in the agreed upon Rule of Procedure
- Maintain the program identity of the HRC as a collective impact program of the participating partners, including NRPC.
- Provide positions to staff the Healthy Roots Collaborative, including program
  management, farm viability, other direct service, farm to school and gleaning. Initial
  staffing will include compensation at an equal or greater amount and comparable
  benefits. This staff includes one full-time and one-part time staff.
- Develop, document, and communicate onboarding process for HRC staff.
- Develop a process for any current CVOEO staff that will fall under the umbrella of the Healthy Roots Collaborative.

#### Reporting

CVOEO will work with the HRC Advisory Committee and program staff to compile mid-year and end of year reporting on outcomes of the program. These reports will be presented in March and October each year.

#### **Funding**

Any existing funds and/or grants will be transferred from NRPC to CVOEO. HRC staff will work with funders and NRPC to update current contracts.

#### Duration

This MOU is at-will and may be modified by mutual consent of authorized officials from NRPC and CVOEO. This MOU shall become effective upon signature by the authorized officials from NRPC and CVOEO and will remain in effect until modified or terminated by any one of the partners by mutual consent OR with 90 days written notice to terminate from either party. In the absence of mutual agreement by the authorized officials from NRPC and CVOEO this MOU shall end on October 1, 2027.
